SUTTON GREEN PRIMARY SCHOOL RESPONSIBLE INTERNET USE

We use the school computers and Internet connection for learning.
These rules will help us to be fair to others and keep everyone safe.

- I will ask permission before entering any Website, unless my teacher has already approved that site.
- On a network, I will use only my own login and password, which I will keep secret or the login and password given by my teacher.
- I will not look at or delete other people's files.
- I will not bring floppy disks or flash drives into school without permission.
- I will only e:mail people I know, or people my teacher has approved.
- The messages I send will be polite and sensible.
- When sending e:mail, I will not give out my personal details, or arrange to meet someone.
- I will ask for permission before opening an e:mail or an e:mail attachment.
- I will not use Internet chat.
- If I see anything I am unhappy with or I receive messages I do not like, I will tell a teacher immediately.
- I know that the school may check my computer files and may monitor the Internet sites I visit.
- I understand that if I deliberately break these rules, I could be stopped from using the Internet or using computers.

The school may exercise its right by electronic means to monitor the use of the school's computer systems, including the monitoring of websites, the interception of e:mail and the deletion of inappropriate materials in circumstances where it believes:
unauthorised use of the school's computer system is or may be taking place
or the system is or may be being used for criminal purposes
or for sorting text or imagery which is unauthorised or unlawful.
